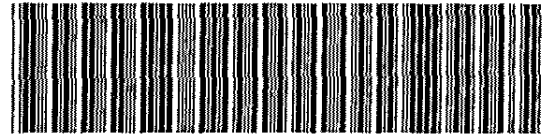



The effective date of these Articles of Incorporation shall be the date of filing.

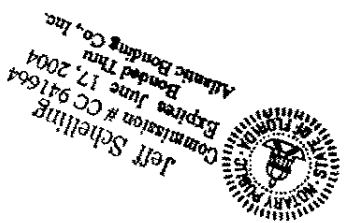
