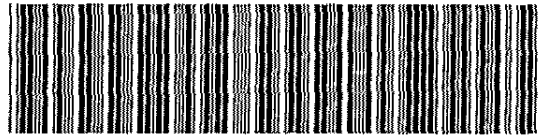

**ARTICLES OF INCORPORATION
OF
BROMLEY LOCK & BATH, INC.**

ARTICLE I - NAME

The name of this corporation is **BROMLEY LOCK & BATH, INC.**

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

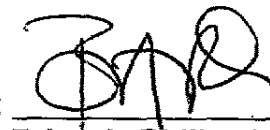

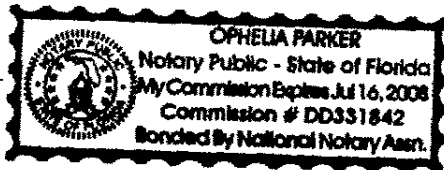

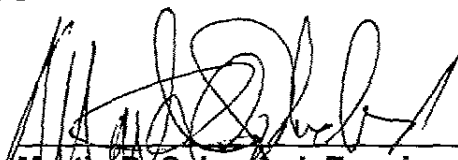
