## FIRST AMENDMENT TO THE ARTICLES OF INCORPORATION OF BROMLEY LOCK & BATH, INC.



Pursuant to the provisions of Section 607.1006 of the *Florida Statutes*, Bromley Lock & Bath, Inc., a corporation organized and existing under the laws of the State of Florida, hereby adopts the following Articles of Amendment to its Articles of Incorporation:

#### Section 1 - Name
