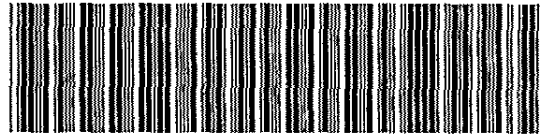


ARTICLES OF INCORPORATION
