I the undersigned, desiring to become a body corporate in compliance with Chapter 607 and/or Chapter 621, F.S. (Profit), for the purpose hereinafter stated and set forth, do hereby file in the office of the Secretary of State of Florida this, my Certificate of Incorporation, in accordance with the laws of the State of Florida, and I do hereby set forth and certify as follows:

#### ARTICLE I NAME
