ARTICLES OF INCORPORATION
OF
WILLIAM ARNEY ENTERPRISES, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Article of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be WILLIAM ARNEY ENTERPRISES, INC.

ARTICLE II. PRINCIPAL OFFICE

The principal office of business of this corporation shall be 816 Marvin Road, Ormond Beach, Florida 32176, and the mailing address of this corporation is the same.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one hundred (100) shares having a par value of one dollar (\$1.00) per share.
