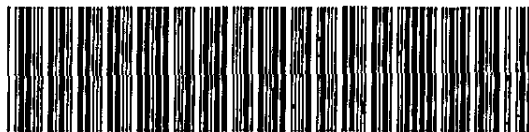

**ARTICLE I
Name**

The name of the corporation shall be Sunshine Snack and Beverage, Inc and its initial place of business shall be at P.O. Box 7904 in the City of Seminole, in the County of Pinellas and State of Florida.

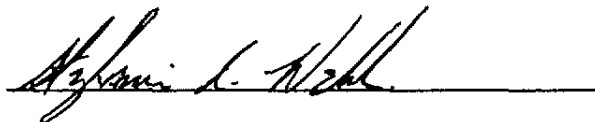
