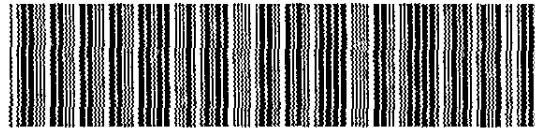

ARTICLES OF INCORPORATION

OF

ADVANCED LEGAL ALTERNATIVES, INC.

The undersigned subscriber, a natural person competent to contract for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation for such corporation.

ARTICLE I

The name of this corporation shall be, Advanced Legal Alternatives, Inc.

Its principal office shall be at 450 South Federal Highway, Suite 101, Stuart, Florida 34994 or at such other place as may be designated, from time to time, by the Board of Directors.

ARTICLE II

The general nature of the business and the object and purpose for which the corporation is organized is to operate a legal document typing service and shall include the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE III

The street address of the initial registered office of this corporation in the State of Florida shall be 450 South Federal Highway, Suite 101, Stuart, Florida 34994 . The initial registered agent at such address is Ricky Lenn Weaver, Jr.

ARTICLE IV

The aggregate number of shares which this corporation shall have authority to issue shall be one hundred (100) shares, all of which shall be common shares with a par value of \$1.00. In the event that a shareholder desires to sell his shares, he must first offer them for sale to the remaining shareholders; it being the intention hereof to give the remaining shareholders a preference in the purchase of same and any sale of shares in violation of this provision is null and void. A shareholder desiring to sell his shares shall file notice in writing of his intention with the President or Secretary of the Corporation, stating the terms of the sale, and, unless such terms are accepted by any or all of the remaining shareholders within thirty (30) days thereafter, they shall be deemed to have waived their preference of purchasing such shares and he shall be at liberty to sell to anyone else.

ARTICLE V

The business of this corporation shall be conducted by a Board of Directors, which shall consist of one (1) Director initially. The number of Directors may be increased from time to time in accordance with By-Laws adopted by the shareholders. The name and address of the initial Board of Directors is: Ricky Lenn Weaver, Jr., President, 5313 Northeast 224th Street, Okeechobee, Florida 34972.

ARTICLE VI
