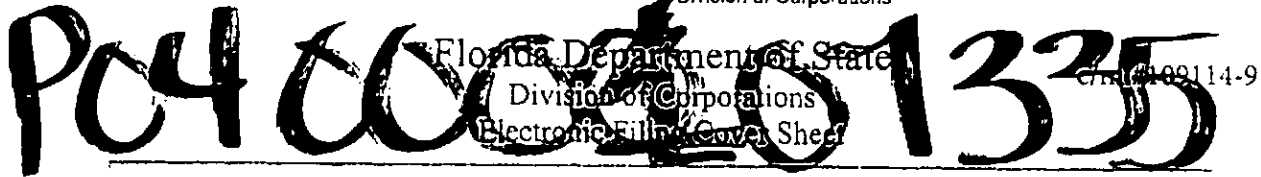

ARTICLES OF INCORPORATION


"ARTICLE I. NAME
