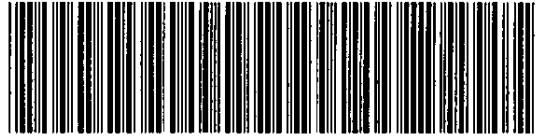

FIRST: The name of the corporation is AMERICAN INTERNATIONAL TRADE CENTER CORPORATION (the "Company").


SECOND: The document number of the Company is P04000107624.
