

ARTICLES OF INCORPORATION

OF



C.J.M. INVESTMENT PROPERTIES OF WEST FLORIDA, INC.

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the Corporation is C.J.M. INVESTMENT PROPERTIES OF WEST FLORIDA, INC., (hereinafter, "Corporation").

ARTICLE 2 - PURPOSE OF CORPORATION

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE 3 - PRINCIPAL OFFICE

The address of the principal office of this Corporation is 764 Samantha Drive, Palm Harbor, Florida 34683 and the mailing address is the same.

ARTICLE 4 - INCORPORATOR

ARTICLE 7 - CORPORATE CAPITALIZATION

- 7.1 The maximum number of shares that this Corporation is authorized to have outstanding at any time is **TEN THOUSAND (10,000)** shares of common stock, each share having the par value of **ONE CENT (\$.01)**.
