

#### ARTICLE I. CORPORATE NAME.

The name of this corporation is DOMINION ENTERPRISES OF JACKSONVILLE, INC.

#### ARTICLE II. PRINCIPAL OFFICE.

The price, terms and other provisions regarding this restriction may be specified by written agreement among the Shareholders, which agreement may expand this Article and which may also include the Corporation as a party. These restrictions are intended to preserve exemptions under federal and state securities laws, to provide for orderly changes in ownership of shares, and to serve other reasonable purposes.

#### ARTICLE X. ELECTION AS AN S CORPORATION.

The corporation elects to be an "S" Corporation. The corporation has filed the appropriate form 2553 with the Internal Revenue Service pursuant to section 1362 of the Internal Revenue Code.

#### ARTICLE XI. AMENDMENT.

The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and any right conferred upon the Shareholders is subject to this reservation.
