I.

The name of the corporation is Lynx Global Corp. (the "Corporation").

II.

Article IV of the Articles of Incorporation of the Corporation is hereby amended to read in its entirety as follows:

ARTICLE III

The corporation is authorized to issue 200 of One Dollar per value of common stock, which shall be designated as "common stock".

This Amendment to the Articles of Incorporation was duly adopted pursuant to Section 607.1003 of the Florida Business Corporation Act by the unanimous resolution of the Board of Directors and the sole shareholder of all of the issued and outstanding shares of Common Stock of the Corporation, effective as of the close of business the 30th day of September 2012.
