

ARTICLES OF INCORPORATION OF

Double Eagle Rare Coins, Inc.

The undersigned, acting as incorporator, and for the purposes of forming a corporation pursuant to Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I -- NAME OF CORPORATION

The name of this corporation being:

ARTICLE II -- PLACE OF CORPORATION


