# ARTICLES OF INCORPORATION

## ARTICLE I

#### NAME

The name of this corporation is:

#### ARTICLE II

# **DURATION**

This corporation is to exist perpetually. It shall commence its existence upon the filing of these Articles of Incorporation.

# ARTICLE III

# **PURPOSE**

This corporation is organized for the purpose of transacting any and all business permitted under the laws of the United States of America and the laws of the State of Florida.

# **ARTICLE IV**

#### CAPITAL TO BEGIN BUSINESS

This corporation is authorized to issue one hundred (100) shares at five dollars (\$5.00) dollars par value.

Shares may be issued for such consideration as is determined from time to time by the stockholders.

This power which is hereby reserved unto the stockholders by right, may, and is hereby delegated, unto the Board of Directors. The Board may issue the shares of this corporation for such consideration as is determined from time to time by action communicate to the Board, in writing, their decision to determine the consideration or issuance of non issue or sale of Treasury shares. Every shareholder, upon the sale for cash on any new stock of this corporation of the same class, class or series as that which he already holds, shall have the right to purchase his pro-rate share thereof (as nearly as may be done without issuance of fractional shares) at the price which is offered to others.

#### INDEMNIFICATION
