**ARTICLES OF DISSOLUTION

Pursuant to the provisions of Sections 607.1402 and 607.1403 of the Florida Business Corporation Act, **Sinermidia Corp.**, a Florida corporation (the "Corporation"), hereby files the following Articles of Dissolution for the purpose of dissolving the Corporation:

1. The name of the Corporation is: **Sinermidia Corp.** The Document Number of the Corporation is P04000108480. The filing date of the Articles of Incorporation of the Corporation was July 22, 2004.
