## ARTICLES OF INCORPORATION

OF

## ARTICLE I

The name of this corporation shall be:

## <u>ARTICLE II</u>

However, an exception is nade to the above in relation to matters as to which he or she shall be finally adjudged in such action, suit or proceeding to have been derelict in the performance of the duties imposed in him as such Director. The right of indemnification herein provided for shall not be exclusive of other rights to which any such person may now or hereafter be entitled as a matter of law.
