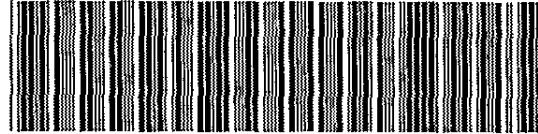

**SECOND:** The date of the amendment's adoption: October 1, 2006.

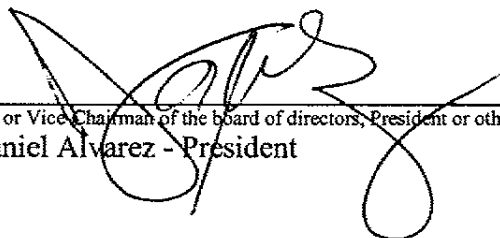
**THRID:** The amendment was approved by the shareholder. The number of votes cast was sufficient for approval.
