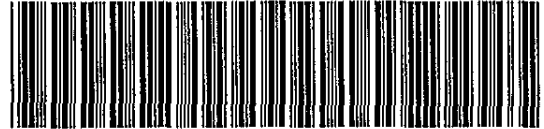

ARTICLE I—NAME

The name of this corporation is AHIZA HERNANDEZ JOHNSON, P.A.

ARTICLE II—DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III—PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business to provide legal services to the public as a law firm, including but not limited to those powers enumerated in the Florida Statutes Section 607.0302 et seq., as amended, and the doing of all lawful things related thereto.

ARTICLE IV—CAPITAL STOCK

This corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock which shall be designed as "Common Shares."

ARTICLE V—PRE-EMPTIVE RIGHTS

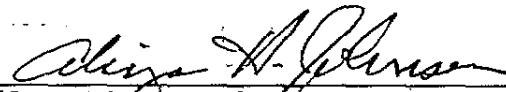
