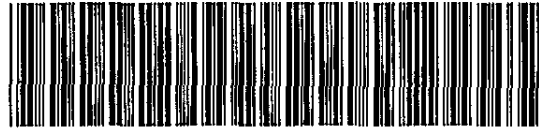

Article I
