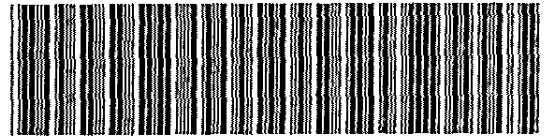

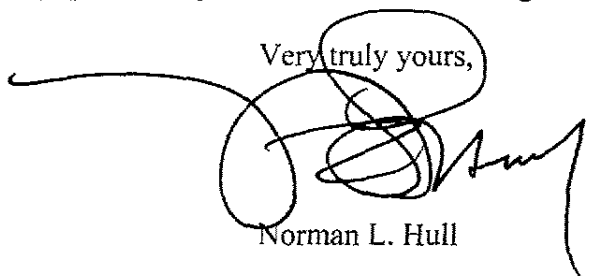

ARTICLES OF INCORPORATION

TYMUR SERGA ENTERPRISES, INC.

The undersigned incorporator, for the purposes of forming a corporation under the laws of the State of Florida, hereby certifies as follows:

Article I

The name of the corporation shall be TYMUR SERGA ENTERPRISES, INC.

Article II

The corporate existence shall begin upon the filing of these Articles with the Department of State of the State of Florida. The duration of the corporation shall be perpetual.

Article III

The corporation is formed for the purpose of engaging in the business of general building construction, both new and renovations. This corporation may also engage in any lawful business for which a corporation may be incorporated under the laws of the State of Florida.
