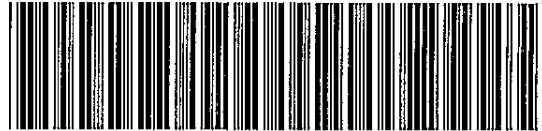

The undersigned does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "corporation") is Corporate Fix, Inc. The street address of the principal office of the corporation is 5711 Aspen Ridge Circle, Delray Beach, Florida 33484. The mailing address, wherever located, of the corporation is 5711 Aspen Ridge Circle, Delray Beach, Florida 33484

SECOND: The purposes for which the corporation is organized are to engage in any lawful business for which corporations may be organized under the Florida Business Corporation Act.

THIRD: The number of shares that the corporation is authorized to issue is 1,000, all of which are of a par value of \$.01 dollars each and are of the same class and are Common shares.
