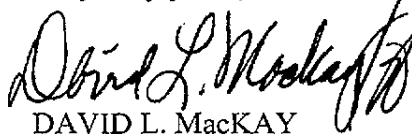

The street address of the initial registered office, the principal office and mailing address of the corporation is 1726 Northeast Eighth Road, Ocala, Florida, 34470.

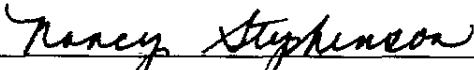
