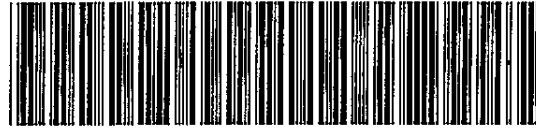

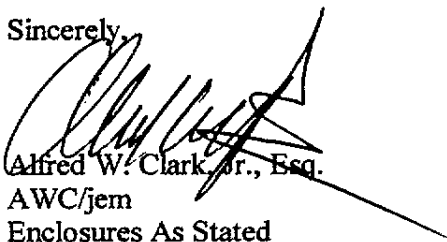

The undersigned, for the purpose of forming a corporation under the General Corporation Act, and in compliance with Chapter 621, Florida Statutes, hereby adopts the following Articles of Incorporation.

**ARTICLE I: CORPORATE NAME**

The name of this corporation shall be **D&M SUNSET PRODUCTS, INC.**

**ARTICLE II: PRINCIPAL OFFICE**
