ARTICLES OF INCORPORATION

OF

CADES COVE COMMUNITY DEVELOPERS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the Corporation shall be Cades Cove Community Developers, Inc.

ARTICLE II

ARTICLE III
