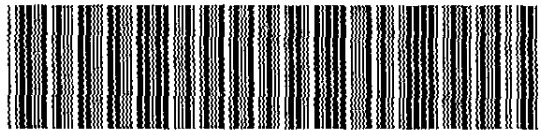

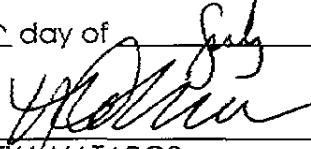
IX. SUBSCRIBER AND INCORPORATOR

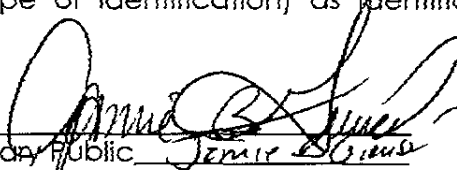

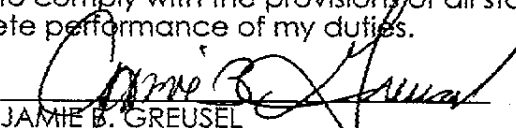
