CERTIFICATE OF ARTICLES OF INCORPORATION PARTICLES

The undersigned for the purpose of forming a corporation under the laws of the State of Florida, by and under the provisions for the formation, liability, rights, privileges and immunities of a corporation for profit, adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be **OLYMPIC CONSTRUCTION**, **GLASS & REALTY**, **INC.**,: the principal office is located at 8604 Tangle Vine Lane, Apartment 9-208, Tampa, Florida 33614, and the mailing address is: P. O. Box 237, Naples, Florida 34106.


