The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I - Name**

The name of this Company shall be: FLORIDA INSURANCE STATISTICAL ASSOCIATION, INC.

**ARTICLE II - Address**

The principal place of business and mailing address of this Company shall be 2941 Donnylane Boulevard, Columbus, Ohio 43235-3228 and such other place or places as may be designated from time to time.

**ARTICLE III - Duration**

This corporation shall have perpetual existence.

**ARTICLE IV - Purpose**

The purpose of the corporation includes, without limitation, to:

- (a) establish and maintain effective liaison with the State of Florida Department of Financial Services Office of Insurance Regulations and other Florida regulatory authorities;
- (b) obtain, compile and analyze such statistical and other data and information as may be necessary or appropriate in connection with rate-making operations or statistical reporting to Florida regulatory authorities;
- (c) acquire, publish and distribute information relative to the business of property and homeowners insurance and of interest generally to the members of the Corporation and the general public;
- (d) furnish upon request of any member or subscriber, upon whose risk a rate has been made, information as to such rate, including the method of computation;

- (f) engage in legislative activity germane to the operation of the rating bureau; and
- (g) do such other related acts and things, including the making and performing of any contracts, which are necessary or desirable to accomplish the purposes set forth herein.

#### ARTICLE V - Capital Stock

This corporation is authorized to issue 10,000 shares of common stock, which shall be designated as "Common Shares." The par value of each share of stock shall be One Cent (\$.01).

#### ARTICLE VI - Initial Registered Office and Agent
