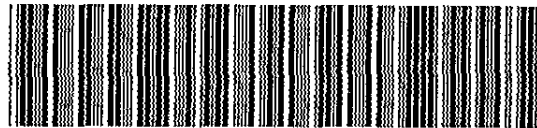



The undersigned, a natural person of an age of eighteen (18) years or more, acting as the incorporator of a corporation under the Florida-Business Corporation Act, hereby certifies as follows:

ARTICLE - I

Name

The name of this corporation is LAO NATIONAL FINANCIAL CORPORATION

ARTICLE - II

Purposes

The purposes for which this corporation is organized are as follows:

- (a) to engage in the business of savings, loans, and other financial services in all lawful activities which are necessary, convenient, and suitable in furtherance of such business and
- (b) to engage in any lawful activity for which corporation may be organized under the State of Florida Law and to exercise general or specific power now or hereafter granted to corporations under the Florida Law.
