ARTICLES OF INCORPORATION OF:

JML OVIDIO CORPORATION

The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE VII AMENDMENT

These articles of Incorporation may be amended in the manner provided by law. ARTICLE IX POWER OF CORPORATION
