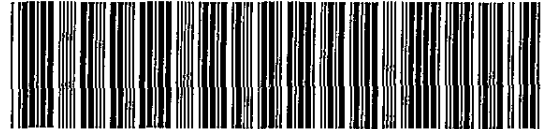

**Article I
Corporate Name**

The name of the corporation is TOPPINO LANDSCAPING, Inc.

**Article II
Principal Office**

The principal place of business of this corporation is 330 Avenue C, Key West, Florida 33040. The mailing address of this corporation is P.O. Box 5721, Key West, Florida 33045-5721.

**Article III
Purpose**

The purpose for which this corporation is organized is to engage in landscaping and grounds keeping, as well as to carry on any and all incidental business.

**Article IV
Capital Stock**

The maximum number of shares this corporation is authorized to issue is one (100) hundred shares, all of which shall be common shares. The corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than thirty-five (35) natural persons, or the estate of such natural persons. Additionally, no stock shall be issued or transferred to a nonresident alien. 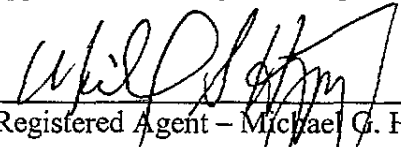

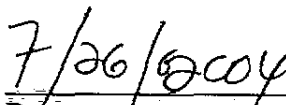

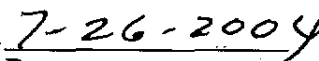
