#### ARTICLES OF INCORPORATION OF:

## FORTUNE SERVICES, CORP.

The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

#### ARTICLE I - NAME

The name of this corporation is FORTUNE SERVICES, CORP. (Hereinaster, "Corporation").
