ARTICLES OF INCORPORATION FOR RK EXOTIC INDIAN MARBLE & GRANITE IMPORTS, INC. 27 AHASSE FLORIDE

The undersigned subscribers hereby associate themselves together to form a corporation for profit under the laws of the STATE OF FLORDIA: and hereby adopt the following ARTICLES OF INCORPORATION.

ARTICLE I NAME
