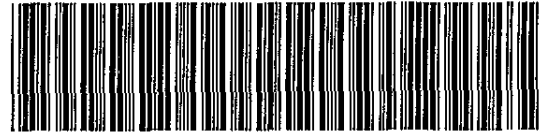

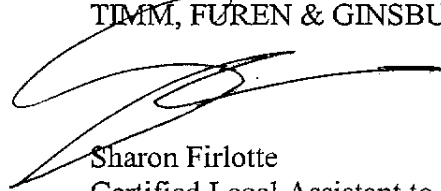

ARTICLE 1. - NAME

The name of the corporation is D.I. OF SARASOTA, INC.

ARTICLE 2. - PRINCIPAL OFFICE

All shareholders are entitled to cumulate their votes for directors.

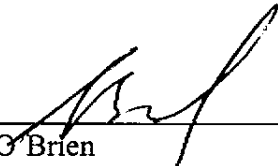
ARTICLE 10. - INDEMNIFICATION

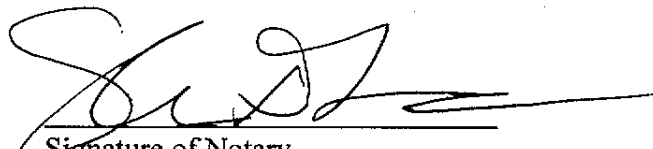

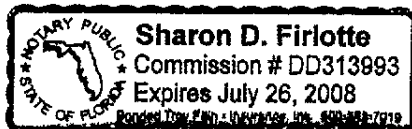
