ARTICLES OF INCORPORATION OF NAT COOPER, INC.

(I)

The Name of the Corporation is Nat Cooper, Inc.

(II)

The Corporation is organized pursuant to the provisions of the Florida Business Corporations Act.

(III)

The period of its duration is perpetual.

(IV)

The Corporation is a corporation for profit and is organized for the following purposes:
