**ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION  
OF A. J.'s TRACTOR SERVICE, INC.**

By these Articles of Amendment, A. J.'s Tractor Service, Inc. ("Corporation"), amends its Articles of Incorporation pursuant to the provisions of Chapter 607, Florida Statutes, and states:

1. The name of the Corporation is A. J.'s Tractor Service, Inc.
2. Upon the unanimous affirmative vote of not less than one hundred (100%) percent of the incorporator and the members of the Board of Directors (said number of votes cast being sufficient for approval), the following amendment to Article VIII was adopted on July 28, 2004:

[New language is underlined; deleted language is stricken through]

**"ARTICLE VIII  
OFFICERS**

The affairs of the Corporation shall be administered by the officers designated in the Bylaws. The officers shall be elected by the Board of Directors ~~at the first meeting; as provided in the Bylaws; provided, however, the initial officers of the Corporation shall be and are hereby appointed as follows:~~

**Anthony J. Renguso; President, Secretary and Treasurer."**

3. Members are not entitled to vote on proposed amendments. The date of adoption of the amendment by the Board of directors ~~and shareholders was July 28, 2004.~~
4. Except to the extent of the amendment set forth above, the terms and provisions of the Articles of Incorporation are hereby ratified and confirmed in their entirety.
