ARTICLES OF INCORPORATION

OF.

F & B SCHOLZ, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME & ADDRESS

The name of this Corporation is F & B SCHOLZ, INC. The principal office, if known, or the mailing address of the Corporation is 1027 S.E. 50th Terrace, Ocala, Florida 34471.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

The general purposes for which the Corporation is organized are the following:
