ARTICLES OF INCORPORATION OF AllStar Transfers, Inc.

TALLAHASSEE FLORIDA

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation is AllStar Transfers, Inc. with a principal office and mailing address of .

ARTICLE II - COMMENCEMENT AND DURATION
