ARTICLES OF AMENDED AND RESTATED TO ARTICLES OF INCORPORATION OF CATHERINE GIBSON CONSULTING, INC. U4 OCT -7 PM 1: 11 SECRETARY OF STATE TALLAHASSEE, FLORIDA

Pursuant to the provisions of section 607.1007, Florida Statutes, this Florida profit corporation adopts the following Articles of Amended and Restated to its Article of Incorporation.

ARTICLE I – NAME

The name of this corporation is Catherine Gibson Consulting, Inc, and is located at 338 Largovista Drive, Oakland, Florida, 34787 and the mailing address is the same.

ARTICLE II – DURATION

This corporation shall have a perpetual existence commencing upon the filing of these Articles of Incorporation by the Department of State.

ARTICLE III – PURPOSE
