ARTICLES OF INCORPORATION

OF

NEW LIFE HOME IMPROVEMENTS, INC.

The undersigned natural person, being of legal age, does hereby subscribe for the purpose of forming and organizing a corporation for profit under the provisions of the Florida Business Corporation Act, and hereby adopts the following Articles of Incorporation covering the existence and organization of this corporation.

ARTICLE I NAME

The name of this corporation shall be New Life Home Improvements, Inc.

ARTICLE II PRINCIPAL OFFICE

The street address of the initial principal office is 306 Olive Avenue, Nokomis,

ARTICLE III CAPITAL STOCK

ARTICLE VI INCORPORATORS

ARTICLE VII INITIAL BOARD OF DIRECTORS

The initial Board of Directors shall consist of the following officers, and the name and address of the President and Secretary of this corporation shall be Graham Custer, 306 Olive Avenue, Nokomis, Florida 34275. The name of the Vice President and Treasurer of this corporation shall be Nick Miller, 306 Olive Avenue, Nokomis, Florida 34275.

VIII BOARD OF DIRECTORS

This corporation shall be managed by a Board of Directors, the number of which will be determined in the bylaws of the corporation. The Board of Directors shall elect the officers of the corporation, which shall consist of a President, a Vice President, and a Secretary/Treasurer, and such additional officers as the Directors may provide for. The shareholders and Board of Directors may take any action that could be taken at a meeting, without a meeting, provided written consents are signed and filed in accordance with the Florida Business Corporation Act.

ARTICLE XI INDEMNIFICATION

This corporation shall indemnify and save its officers and directors of and from any suits, actions, or judgments arising out of their conduct of the affairs of the corporation, in which any liability shall be alleged or imposed upon any of the corporation's officers or directors, from any act done by any such officers or directors in behalf of the corporation, and the corporation further shall pay all costs, legal expenses, and any other charges that said officers or directors may incur in the defense of any claim, suit, or action that may be instituted against said officer or director in his or her individual capacity, it being the purpose and intent that the corporation shall save its officers and directors harmless from any action taken by them in its behalf, to the maximum extent indemnification is permitted under the Florida Business Corporation Act.

ARTICLE XII BYLAWS

This corporation shall have perpetual existence, unless sooner dissolved according to law.
