ARTICLE I - NAME

The name of this corporation shall be:

ARTICLE II - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:

To engage in services and activities associated with the listing and sale of real estate, both commercial and residential, as a sales associate.
