


ARTICLE VII AMENDMENTS

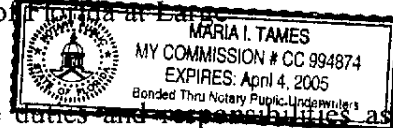
