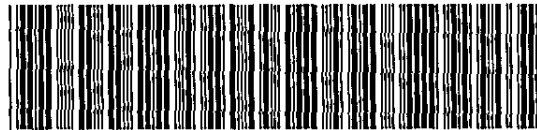

OF

The undersigned subscriber to these Articles of Incorporation, is a natural person, competent to contract and hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is BY CLIPBOARD US, CORP.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of this corporation is 3118 NW 1ST Street, Miami, Fl 33125. The Board of Directors may, from time to time, designate such other address and place for the principal office of this corporation as it may see fit.

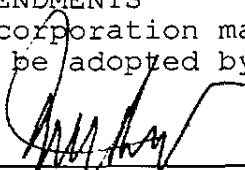
