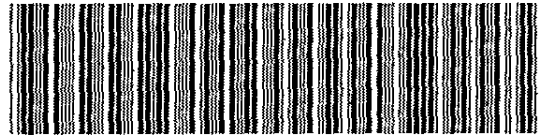

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: InCom Properties Incorporated.

ARTICLE II

The street address of the principal office of the Corporation is: 1655 Breakers West Blvd., West Palm Beach, Florida 33411.

ARTICLE III

The maximum number of shares this Corporation is authorized to issue is 1000, par value \$1.00 per share, all of which shall be Common Shares.
