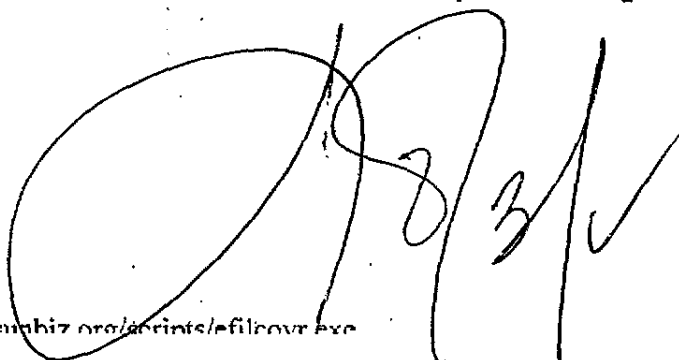

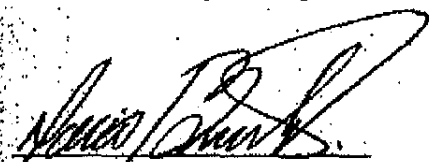
ARTICLE X - Liquidation

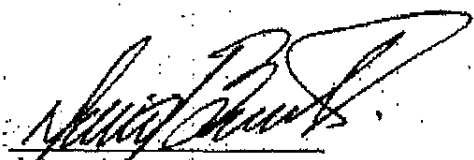

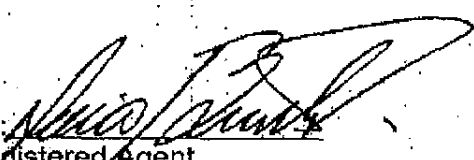
