ARTICLES OF INCORPORATION OF J B & E ASSOCIATES, INC.

ARTICLE I-NAME

The name of this corporation is J B & B ASSOCIATES, INC. The address of this corporation is 19442 NW 7 CT., MIAMI, FL 33159.

ARTICLE II-DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III-PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business under the laws of the State of Florida and the United States of America.

ARTICLE IV-CAPITAL STOCK

This corporation is authorized to issue 750 shares of One Dollar (\$1,00) par value common stock which shall be designated as "Common Shares."

ARTICLE V-PRE-EMPTIVE RIGHTS

This provision is to protect shareholders from dilution of their proportionate interest, control and value of J B & B ASSOCIATES, INC. stock.

A shareholder may waive his preemptive right upon written notice to the Board and such waiver is irrevocable.
