**ARTICLES OF AMENDMENT TO THE
AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF SAND LAKE HOSPITALISTS, P.A.**

THE UNDERSIGNED, Jauvid Ayadi, M.D., CEO of SAND LAKE HOSPITALISTS, P.A., a Florida corporation (the "Corporation"), for and on behalf of the Corporation, hereby executes these Articles of Amendment to the Amended and Restated Articles of Incorporation of the Corporation:

ARTICLE FIRST: The name of the Corporation is SAND LAKE HOSPITALISTS, P.A.

ARTICLE SECOND: The amendment to the Amended and Restated Articles of Incorporation of the Corporation effected by these Articles of Amendment is that ARTICLE I of the current Amended and Restated Articles of Incorporation is amended to provide as follows:

"ARTICLE I - NAME OF CORPORATION. The name of this Corporation shall be COAST TO COAST PHYSICIANS ALLIANCE, P.A."
