**ARTICLES OF AMENDMENT TO THE  
AMENDED AND RESTATED ARTICLES OF INCORPORATION  
OF COAST TO COAST PHYSICIANS ALLIANCE, P.A.**

THE UNDERSIGNED, Jauvid Ayadi, M.D., CEO of COAST TO COAST PHYSICIANS ALLIANCE, P.A., a Florida corporation (the "Corporation"), for and on behalf of the Corporation, hereby executes these Articles of Amendment to the Amended and Restated Articles of Incorporation of the Corporation:

**ARTICLE FIRST:** The name of the Corporation is COAST TO COAST PHYSICIANS ALLIANCE, P.A.
