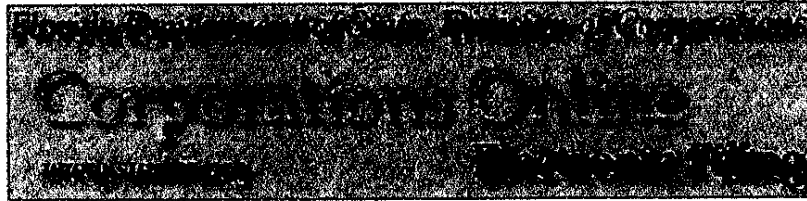

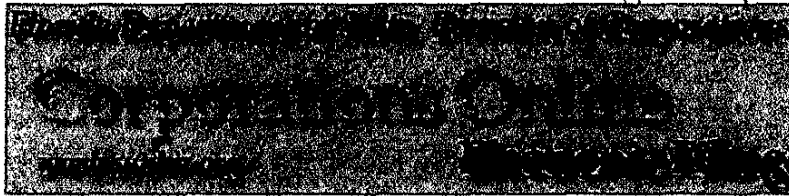

To Whom It May Concern,

Back on April 3, 2006, I responded, to and paid for my Annual Report for my small one man company, Kugelman Concepts, Inc., via the internet – or so I thought I did. This business although was “born” in August of 2004 has only been utilized as a company since October of 2005. I am the first to admit I’m much better in the field than figuring out the paper work of running a company. I’ve been learning as I go along. I will also be the first to admit that I think I was born a generation too early for computer usage, I get frustrated easily when surfing around on the web.

I mention this fact to you, as on June 30, 2006, I received a postcard advising me of the State’s intent to dissolve my business unless an Annual Report is filed. I wasn’t concerned, as I knew I had already done this a few months back. Using my home computer I had answered the questions asked of me and checked the appropriate boxes on the form advising the State that I had no changes to make. I even printed out a receipt to keep in my file confirming my payment. Feeling quite confident of your error I called the Divisions of Corporations this morning to advise you of my payment ID number and reference number in order to correct your records.

After a bit of searching around in the history of my account, the person I spoke with by phone advised me that I had not paid or filed my Annual Report, but rather just paid for a printed out “certificate” for the previous years payment. Somehow I must have aborted or not confirmed the transaction properly when prompted on the web page, thus not registering the submission. Imagine my shock and disbelief – that it was my records in error, not the State’s! Because I am a new business owner and I was confused in making my payment on your web page, she went on to suggest that I send the State my regular payment for the filing and a copy of any correspondence, which I printed out the day I thought I had paid and filed, along with a letter of explanation. The department would review everything and possibly waive the late fee.

Please accept this letter as my request to waive the late fee imposed. Also, please accept the enclosed check, (# 1010) as payment for this years Annual Report. I would appreciate it if you would also send me via US mail a receipt that this has been paid in full so I can add the corrected documents to my records.
