The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be Miami Stock Photos, Inc.

ARTICLE II - COMMENCEMENT & DURATION

The corporation shall commence its existence on August 1, 2004 and shall exist perpetually unless sooner dissolved according to law.

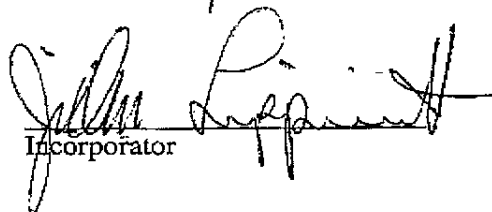
ARTICLE IX - AMENDMENTS TO ARTICLES

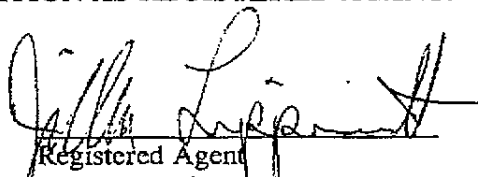
